## **RESEARCH GRANT GUIDELINES**

8. All requests for Research Grants must be independently initiated in writing by the individual or research entity that proposes to conduct the research and must include the following information:

- A protocol, statement of work, study abstract or other information describing the research to be performed, including a project timeline
- A description of the qualifications of the research institution and investigators
- A budget for the research project
- A statement describing how the research will serve one or more of the purposes described in paragraph 3 above.
- Timeline for use of funds and completion or research
- Contact information for follow-up by ClearPoint Neuro (including e-mail address)
